# NYS WETLANDS FORUM 2018 CONFERENCE HIGHLIGHTS

Since its incorporation in 1994, the NYS Wetlands Forum (NYSWF) has offered a yearly conference for its members and all others interested in wetlands and wetland related topics. The yearly conference brings together a mix of professionals from the public and private sectors and colleges and universities to share their knowledge, research, and lessons learned from across the state. This year's conference was held at the Harbor Hotel in Watkins Glen, NY. This was a new location for the NYSWF conference that took advantage of a fun little Finger Lakes city, a classy hotel, and the surrounding wetland and aquatic resources.

The theme of this year's conference was "Growth and Resources, Finding the Balance." This is an issue of great concern in the Finger Lakes region, with the popularity of the lakes for recreation, tourism, and an outstanding wine industry, a balance is needed to ensure the lakes remain healthy.

We were very fortunate to have Aimee Clinkhammer from the NYS Department of Environmental

Conservation Finger Lakes Water Hub as our Keynote Speaker, discussing water quality issues, concerns and mitigation within the Finger Lakes region.

Concurrent sessions were held on Day 1, providing the attendees with numerous topics to choose from including some classic discussions of wetland mitigation and restoration strategies, classification and functional assessment, habitat restoration, invasive species, and many more. A very interesting session on public involvement and stewardship featured Rita Locke Pettine with a discussion of a mobile augmented reality demonstration project at an outdoor living museum and Dominic Cordisco with a case study on the impact of social media and "fake news" on the LEGO land project in the Lower Hudson region. Day 2 featured the usual legislative and regulatory discussion but in a panel format. Many great speakers from both the regulatory, resource agency, and private sector provided both regulatory updates and perspectives on the most recent hot issues.

The annual luncheon and business meeting featured some really great food, a little business, and the opportunity to recognize two students for their excellent research projects: Michael McGowan and Evie Brahmstedt. (Continued on page 3)



## **NYSWF 2018 STUDENT GRANT WINNERS**

If you attended our 2018 Conference and Business

Meeting you may recall this year's NYSWF \$500 scholastic grant recipients were Evie Brahmstedt, of Clarkson University, and Michael McGowan, studying at the Rochester Institute of Technology. Evie described her educational goals as gaining experience and background knowledge required for a career as a professor at a research institution studying freshwater wetlands and advocating for science in policy. Toward that end, Evie's ongoing work associated with her Ph.D. thesis, "Mercury cycling in riparian wetlands along the St. Lawrence River" was submitted to the Forum for consideration. As Evie explained it, the International Joint Commission (IJC) has embarked on a new water level regulation plan (Plan 2014) that will alter water levels above the Moses-Saunders power dam to simulate natural fluctuations and restore biodiversity in the St. Lawrence River. If the dominant macrophyte, Typha, is reduced in abundance, there is potential for soil, containing mercury (Hg), to become mobilized. When water levels decline, nearshore Typha will dry out, along with the soil they have trapped. If this causes a release of Typha downstream, the accumulated mercury-contaminated soil will be released. Evie's intent to study this occurrence, along with her other many accomplishments and ambitions was quite impressive. Michael's research and overall academic progress was also impressive. As a full-time student in the Environmental Science Bachelor's/Master Dual Degree Program, Michael studied the effects of carbon availability, nitrogen availability, and hydrology on denitrification and nitrogen fixation rates in two created wetlands in Perinton, NY. In particular, Michael used an operating waste management/compost site to assess the effect of carbon and nitrogen availability on denitrification and nitrogen fixation rates to improve our understanding of how management techniques can facilitate both the removal of reactive nitrogen and provide habitat in wetlands. As with all our grant recipients, these students represent the future of our wetlands management. Support by the Forum is thought to be a good investment. With thanks for their hard work, the Forum is proud to support their efforts.
